Dear Mr. Peloso:

This letter will confirm that The Law Office of John A. Grant, P. A. law firm (hereinafter referred to as the "Firm"), at your request, will provide legal services to Pasadena Hills Owners Association, Inc. on the terms set forth herein.

- A. Services. - **B.** Fees. Our fees for collection of dues and assessments will be charged on a flat fee basis payable by the association after payment by the owner, or in the case of foreclosure subject to the "safe harbor" provision of Section 720.3085, Florida Statutes, after issuance of a certificate of title to the property. Our fee for a demand letter is \$200.00, and our fee for preparation and recording a lien, and sending an additional letter to the owner after recording the lien, is \$300.00. The association is responsible for the costs associated with certified mail, which we bill at a flat rate of \$10.00 per letter, and for the cost to record the lien, for which we will invoice the association monthly. Our fee for a demand to tenants for rent pursuant to § 720.3085 is an additional \$200.00.

Our fees for all other matters will be determined based on the time spent working on the matter. The following hourly rates will be charged:

Fractions of hours will be recorded in tenths of an hour. Each such period of time recorded is based upon actual work on your particular matter, except that a minimum of one-tenth of an hour will be billed for any particular task. The fee arrangement outlined above covers only legal fees for professional services rendered by the Firm, and does not cover out-of-pocket expenses actually incurred by the Firm on your behalf.

- C. Out-of-Pocket Expenses. In addition to our fees for professional services rendered, any out-of-pocket expenses incurred by us in representing your interests and directly attributable to this matter will be separately charged to you at cost for reimbursement.
- **D.** Billing Procedures/Statements. Our policy is to issue billing statements to our clients on a monthly basis.
