ARTICLES OF INCORPORATION OF PASADENA HILLS OWNERS ASSOCIATION, INC.

A FLORIDA NONPROFIT CORPORATION

ARTICLE 1.

Name

The name of this corporation is PASADENA HILLS OWNERS:
ASSOCIATION, INC.

ARTICLE 11.

Duration

The duration of this corporation shall be perpetual, commencing with the filing of these Articles with the Department of State of the State of Florida.

ARTICLE III.

Purpose

The general purpose of this corporation is to promote the common interests of property owners in Pasadena Hills subdivision in Leon County, Florida. The corporation may undertake any action necessary to further this general purpose. The corporation shall not, as its primary activity, engage in a regular business of a kind ordinarily carried on for profit.

ARTICLE IV.

Dedication of Assets

The property of this corporation is irrevocably dedicated to its purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual; provided that, upon dissolution or final liquidation

the corporation may make distribution to its members as permitted by the court having jurisdiction thereof and no such liquidating payment or distribution shall be deemed to be a dividend or a distribution of income.

ARTICLE V.

Membership

All owners of lots in Pasadena Hills subdivision, paying regular assessments as provided in the bylaws, and agreeing to be bound by the articles and the bylaws, and by such rules and regulations as the Board of Directors may from time to time adopt, are eligible for membership in the corporation. The Board of Directors shall from time to time prescribe the form and manner in which applications may be made for membership.

ARTICLE VI.

Location of Initial Registered Office and Name of Initial Registered Agent

The street address of the initial registered office of this corporation is 1203 Governor's Square Boulevard, Tallahassee, Florida 32301.

ARTICLE VII.

Initial Directors

<u>Incorporator</u>

ARTICLE IX.

Management of Corporate Affairs

(a) <u>Board of Directors</u>: The power of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors. The number of directors of the corporation shall be not less than three; provided, however, that such number may be changed by the addition of members.

Each director shall serve until a successor is appointed.

Each director shall be elected as provided in the Bylaws.

(b) <u>Corporate Officers</u>: The Board of Directors shall elect the following officers: President, treasurer, and secretary and such other officers as the bylaws of this corporation may authorize the directors to elect from time to time. Such officers shall be initially elected at the organizational meeting of the Board of Directors.

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PASADENA HILLS HOMEOWNERS ASSOCIATION, INC.

HE TO

Pursuant to the provisions of Chapter 617 Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed April 6, 1989, #N31566.

<u>First:</u> Article IV of the Articles of Incorporation is hereby deleted and in its stead Article IV shall read as follows:

ARTICLE IV DEDICATION OF ASSETS

The property of this corporation is irrevocably dedicated to its purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof, or to the benefit of any private individual; provided that upon dissolution or final liquidation the assets shall be dedicated to a public body or conveyed to a non-profit organization with similar purposes. Nothing herein shall prevent the corporation from participating in mergers or consolidations with other non-profit corporations organized for purposes similar to the purpose for which this association was organized.

<u>Second:</u> Article V of the Articles of Incorporation is hereby deleted and in its stead Article V shall read as follows:

ARTICLE V MEMBERSHIP

Every person or entity who is a record owner of a fee or undivided fee interest in any lot in Pasadena Hills Subdivision which is subject to assessments by the Association shall be a member of the Association. The Association shall have two classes of voting membership:

Class A. Class A Members shall be all those owners as defined above with the exception of the Developer. Class A Members shall be entitled to one vote for each Lot in which they

when more than one person holds such interest or interests in any Lot, all such persons shall be Members, and the vote for such Lot shall be exercised as they among themselves determine, but in no event shall more than one vote be cast with respect to any such Lot.

Class B. Class B members shall be the Developer. The Class B Member shall be entitled to two votes for each Lot in which it holds the interest required for membership as defined above, provided that the Class B Membership shall cease and become converted to Class A membership when the total votes outstanding in both the Class A and Class B memberships, at which time the Class B membership shall be determined to be a Class A membership and entitled to vote as such.

No member shall be entitled to vote unless such member has fully paid all assessments as provided herein as shown by the books of the Association.

As long as there is Class B Membership the following actions by the corporation will require the prior approval of FHA or VA:

- (a) Annexation of Additional Property
- (b) Mergers and Consolidation
- (c) Mortgage or dedication of common area
- (d) Dissolution and Amendment of the Articles of Incorporation

Third: The following Article is hereby added to the Articles of Incorporation:

ARTICLE X AMENDMENT

The Articles of Incorporation may be amended by the vote of 75% of the membership.

Fourth: These amendments were adopted by the Board of Directors on the $\frac{39}{2}$ day of June, $19\frac{90}{2}$.
