# Agenda Items:

## 1. Insurance Policy

Recently, it has been brought the board's attention the possible need for insurance coverage for the board members. Director at Large Kyle Herman has worked diligently contacting local insurance companies to receive quotes on a variety of coverages. The board discussed options and which type of policy would be best, both in protection and fiscal responsibility. The latest quote Kyle had received was a D&O policy, covering up to \$1,000,000. The board collectively felt this amount of coverage was too high, and because a \$500,000 policy is available, this may be a better option.

<u>Action</u>: Kyle will contact the insurance company and request a quote for the \$500,000 D&O policy. Once he receives it, he will send it to the board members for a careful review before a vote is taken.

## 2. Upcoming Neighborhood Picnic

#### Action:

- Dennis will disseminate a handout to all residents over the weekend of October 21-22 to advertise the picnic to encourage participation.

- Kyle will purchase a sign rider to attach to the existing sign at the front of the neighborhood to add the date and time of the picnic.
- Katie and Selena will provide folding tables for the picnic, Selena will also set up a canopy.
